

## INSTRUCTIONS

**1** The bus stops at this location at listed times. Look for the column of times below the matching symbol in the schedule.

**2** Only certain trips operate along this portion of the route. See the schedule for trips that provide service here.

**T** 1,2,3 Transfer point. Shows where bus intersects with other routes available for transfer.

The bus stops at the times listed below the numbered symbol. Light times are A.M.; bold times are P.M.

The timetable shows when the bus is scheduled to depart. Actual times may vary and depend upon traffic and weather conditions. Arrive at the bus stop 2-3 minutes early to avoid missing the bus.

### Transfers

Transfers are available for 75 cents and can be used when you are traveling more than one bus route. Ask your driver for one as soon as you board the bus. Transfers can only be purchased at the same time as your regular cash fare. Transfers are for use only in continuous direction – from point of origin to point of destination. Transfers are not good for a return trip on the same route, or on any other route returning to your point of origin. Transfers are good only for 90 minutes from the time of purchase and only on the date purchased.

### Connections

Connecting service to Luzerne County buses is available on the #26 Mohican Sun, #28 Pritson, and #31 Old Forge routes.

### Lost & Found

If you leave something on a COLTS bus, you can call 570-346-2061 to see if it was found. Items left at COLTS administrative offices for more than 30 days will be donated to charity.

### Title VI Rights

COLTS does not operate on Sundays.

COLTS does not provide service on the following holidays:

New Year's Day, Memorial Day, July 4, Labor Day, Thanksgiving, and Christmas Day.

All COLTS vehicles are ADA compliant.

### Regular Fares

- Seniors 65 and older ride FREE all the time with a Senior Fare card. These are available through COLTS.
- Cash: \$1.75
- Children 45 inches and shorter and accompanied by an adult ride free.

### COLTS Passes

All COLTS passes are good on LCTA buses, and vice versa.

31-Day Adult Passes: \$60, Adult 10-Ride Passes: \$15.75

**Students with current, valid student ID:**

31-Day Pass: \$28; 31-Day ADULT (red) Student Pass: \$28

Student 10 Ride Pass: \$7.85

Day Pass: \$4

### Reduced Fares

If you are under 65 years old and have a valid Medicare card, you can ride at the reduced rate of half the regular rate. If you have a disability as defined by the Americans with Disabilities Act of 1990, you may be eligible for a Reduced Fare Card.
