County of Lackawanna Transit System (COLTS) was officially certified by the state as a municipal authority in November 1972. COLTS replaced the **Scranton Transit Company**, which provided electric trolley service and bus service for many years. The nation's first successful electric streetcar system began service in Scranton in November 1886. It was these electric trolleys that gave the city its nickname, "**The Electric City.**" Bus service completely replaced electric streetcars in December 1954. The original base fare to ride a COLTS bus was 35 cents.

The original five COLTS board members, appointed by Commissioners Charles Luger, Robert Pettinato, and Edward Zipay, were: Fred Tuckerman, Mrs. James Edmonson, Seymour Hollenberg, Carmine B. Tomaine, and Ernest J. Gazda Sr.

COLTS inherited the Shared Ride Program from Lackawanna County in January 2013. Our current Board of Directors are Larry Wynne, Michael Dougherty, Brian Doughton, Martha Dougher, and Gregg Nieto. The Shared Ride Department offers various programs, such as SEATS, PwD, and the Pennsylvania lottery fund, there are many ways to ride with COLTS.

Public transportation has a long history in Lackawanna County, and COLTS is proud to be your transit provider.

#### **Passenger Code of Conduct**

- 1. All fares must be paid upon boarding.
- 2. Everyone must stand behind the white line before the bus can leave its stop.
- 3. Passengers must be fully clothed, including shirts and shoes, while aboard a COLTS vehicle.
- 4. No eating or drinking, unless medically necessary. Food and drink items must be in a sealed container at all time.
- 5. Alcoholic beverages are prohibited.
- 6. Smoking, e-cigarettes, vaping, and smokeless tobacco are prohibited.
- 7. Hazardous, toxic, or explosive materials may not be brought onto the bus.
- 8. Do not litter on the bus. Please dispose of trash and recyclables properly.
- 9. Yield priority seating to riders with disabilities and seniors.
- 10. Use the stop request cord to signal your stop.
- 11. Aisles and seats must be kept clear of strollers, carts, packages, etc.
- 12. All strollers must be folded no exceptions.
- 13. Do not disturb or harass other passengers or the operator. Loud and disruptive riders will be asked to leave the bus.
- 14. Conversations on cell phones should not distract or disrupt other passengers or the operator. Please keep calls short and quiet!
- 15. Music and audio devices are allowed ONLY with the use of headphones. Volume levels that disrupt the safety of the vehicle operator and passengers will not be permitted.
- 16. Please refrain from cursing and using profanity.
- 17. Guide dogs and service animals are allowed on COLTS buses. A service animal is defined by the Americans with Disabilities Act as "any guide dog, signal dog, or other animal individually trained to work or perform tasks for an individual with a disability, including, but not limited to, guiding individuals with impaired vision, alerting individuals with impaired hearing to intruders or sounds, providing minimal protection or rescue work, pulling a wheelchair, or fetching dropped items." Emotional support animals are not considered service animals.
- 18. Small pets are allowed on the bus in carriers, but the carrier cannot take up a seat of obstruct the aisle.
- 19. If you notice a package left anywhere on the bus, do not disturb it. Instead, please notify the driver immediately.

### Find Out When The Next Bus Is Coming



Message and data rates may apply.

myStop© via text Text "CT" and your bus stop number to 321123.

For example: if you are at Stop 1405, text CT1405 to 321123.

myStop© by phone Dial 570-207-5055 and follow the prompts to enter the Stop ID.

#### Bike Procedure

Most bicycles can be accommodated on COLTS Transit Buses. COLTS cannot transport any bicycle that requires gas, diesel, or any combustible fuel. Each bike rack holds up to two bikes. COLTS subcontracted buses do not have bike rack availability.

If you are considering traveling with a bicycle, please consider the following:

- Before your bus arrives, remove any items that could interfere with the driver's vision or operation.
- Once the bus comes to a complete stop, kindly alert your driver that you will need to secure your bike.
- Carefully, approach the front of the bus, lower the rack, by squeezing the spring- loaded handle. Lift your bike into the wheel well closest to the bus and place the security hook over the tire.

#### Bike space is limited and cannot be guaranteed.

- Kindly remind the driver that you need to unload your bicycle.
- •Then, approach the front of the bus, remove the security hook from the tire, lower your bike and return the bike rack to the upward position.

#### **FARES**

- One Ride Ticket: \$1.75: A ride is one pick up to one drop off.
- Day Pass: \$4 .00: These may be purchased on a bus, and you must tell the operator you would like a day pass before entering any money.
- 10 Ride Student Pass: \$7.85: This pass can be used for 10 rides.
- 31 Day Student Pass: \$28.00: This pass offers unlimited rides for 31 days.
- 31 Day Adult Student Pass: \$28.00: This pass offers unlimited rides for 31 days.
- Transfer: \$0.75: This should be requested when extending a trip, one time, toward your destination for 2 hours. This will not work for a return trip.

#### HOW TO BOARD AND PAY

#### **HOW TO BOARD AND PAY YOUR FARE**

Welcome to COLTS! We are glad you are riding with us today.

Each route follows a set schedule. Paper schedules can be found in the Transit Center. You can also download the **myStop app** to your phone, tablet, or desktop, or check out our website, www.Coltsbus.com for routes, runs, and updates.

Each bus displays the destination on the bus head sign located above the windshield or to the left of the entrance door. If you have questions about the destination for a particular bus, do not hesitate to ask your driver.

Once you have chosen a route, please, arrive at the bus stop 5 minutes prior to scheduled departure time, and prepare to have your fare ready before the bus arrives. Keep a safe distance between you and the bus as it approaches, and wait to board until the bus has completely stopped.

When boarding, please be courteous to passengers who may use a mobility device or have strollers with small children. Please, remember to use the handle rails for assistance.

As you enter, you must pay your fare at the **farebox** as soon as you board.

COLTS offers a variety of bus passes, which are available for purchase in the Transit Center, our website, or local vendors. We recommend purchasing 10 Ride Passes and Monthly Passes in advance. You can also purchase a Day pass for \$4.00 or a \$.75 Transfer when you board your Fixed Route bus. Remember a Day pass allow you to ride all day, and it expires at midnight on the day it is stamped. Transfers expire two hours after purchase and cannot be used for Return Trips. When using a 10 Day pass, you may purchase a Transfer at the time of boarding to extend your trip for use on an alternative Bus. Inform the driver when you board, so the driver can issue you the correct card.

Once you board, insert the pass into **farebox**. Once you see and hear the pass is accepted, you may take your seat. If you hear an alert or see a denial of your pass, both the **farebox** and your operator can assist you.

Some passengers will pay with cash or coin. Insert your bills into the bill slot and your change into the change slot. Depending on the amount, you may be issued a Change Card for the difference. Change Cards do not expire, but remember to keep the Card in good working condition. When the **farebox** indicates that your fare is paid, you may take your seat.

When choosing a seat, COLTS encourages you to follow these simple suggestions:

- •Courtesy seating, located in the front of the bus, meets the needs of all transit customers, especially for passengers use mobility devices or aids, passengers with disabilities or mobility issues, and passengers with strollers and small children.
- •Always remember to stand behind the yellow line at the front of the bus, if there are no seats available.

As you travel, watch and listen for your stop. Be mindful of fellow passengers as they exit the bus along the route.

Announcements for upcoming stops will be made. When you are ready to exit, pull the cord to request a stop. When exiting,

- •Be sure to check your seat for items you may leave behind such as glasses, wallet, purse or any carry on item.
- •We appreciate you keeping our buses clean. Take any garbage with you when you exit.
- •Don't forget to thank your driver!
- •Be careful when stepping onto the curb or street; and
- •If crossing the street, go to the nearest crosswalk or corner, and wait for a safe time to walk.




